THE PERMIT ALLOWS: Temporary installation of a Ferris Wheel with mini golf course on the deck behind the wheel, on the existing lawn area adjacent to the St Kilda Yacht Club building within Catani Gardens between 28 November 2022 and 5 May 2023, in accordance with the following documents, as endorsed by the Executive Director and forming part of this permit:

- Location & Site Plan, prepared by Frontier Heritage, dated 6 October 2022.
- Ferris Wheel Plan, prepared by Frontier Heritage, dated 6 October 2022.
- Provisional Approval Agreement Skyline Ferris Wheel and Mini Golf, prepared by City of Port Phillip, dated 28 July 2022.
- Skyline Attractions Bump-in and Bump-out Schedules, undated.

THE FOLLOWING CONDITIONS APPLY TO THIS PERMIT:

- 1. The permission granted for this permit shall expire if one of the following circumstances applies: the permitted works have not commenced within two (2) years of the original date of issue of this permit, or are not completed within four (4) years of the original date of issue of this permit.
- 2. The Executive Director, Heritage Victoria is to be given one days' notice of the intention to commence the approved works.
- 3. At the conclusion of the event, and prior to 15 June 2023, the following condition reports for the works area within the Catani Gardens are to be prepared by fully qualified professionals (independent from the event) and must be provided for endorsement by the Executive Director, Heritage Victoria and once endorsed becomes part of the permit:
 - Post-event condition report, including impacts and repair actions (including but not limited to aerating, scarification, top dressing, over seeding and fertilising of grassed areas), any variations to the approved documents and recommendations for outstanding repair actions.
 - A soil compaction assessment, based on the condition of the Place after the event, including recommendations for future soil protection.
- 4. The works approved by this permit are to be carried out in accordance with the endorsed documentation, unless otherwise agreed in writing by the Executive Director, Heritage Victoria.

- 5. Should further minor changes in accordance with the intent and approach of the endorsed documentation become necessary, correspondence and supporting documentation must be prepared and lodged in accordance with the permit condition for assessment by the Executive Director, Heritage Victoria who will advise on the approach to be taken to address these matters.
- 6. Approved works or activities are to be planned and carried out in a manner which prevents damage to the registered place. However, if other previously hidden original or inaccessible details of the object or place are uncovered, any works that may affect such items must immediately cease. The Executive Director, Heritage Victoria must be notified of the details immediately to enable Heritage Victoria representatives to inspect and record the items, and for discussion to take place on the possible retention of the items, or the issue of a modified approval.
- 7. All works must cease, and Heritage Victoria must be contacted if historical archaeological artefacts or deposits are discovered during any excavation or subsurface works. Should any munitions or other potentially explosive artefacts be discovered, Victoria Police is to be immediately altered and the site is to be immediately cleared of all personnel.
- 8. The Executive Director, Heritage Victoria must be informed when the approved works have been completed.

NOTE THAT PERMISSION HAS BEEN GIVEN FOR INSPECTIONS OF THE PLACE OR OBJECT TO BE UNDERTAKEN DURING THE CARRYING OUT OF WORKS, AND WITHIN SIX (6) MONTHS OF NOTIFICATION OF THEIR COMPLETION.

TAKE NOTICE THAT ANY NATURAL PERSON WHO CARRIES OUT WORKS OR ACTIVITIES NOT IN ACCORDANCE WITH THE PERMIT OR CONDITIONS IS GUILTY OF AN OFFENCE AND LIABLE TO A PENALTY OF 120 PENALTY UNITS (\$22,190.40 FROM 1 JULY 2022) OR IN THE CASE OF A BODY CORPORATE 600 PENALTY UNITS (\$110,952 FROM 1 JULY 2022) UNDER \$104 THE HERITAGE ACT 2017.

WORKS UNDERTAKEN WITHOUT A PERMIT OR PERMIT EXEMPTION CAN INCUR A FINE OF UP TO 4800 PENALTY UNITS (\$887,616 FROM 1 JULY 2022) FOR A NATURAL PERSON OR 5 YEARS IMPRISONMENT OR BOTH AND UP TO 9600 PENALTY UNITS (\$1,775,232 FROM 1 JULY 2022) IN THE CASE OF A BODY CORPORATE UNDER SECTION 87 OF THE HERITAGE ACT 2017.

THE ATTENTION OF THE OWNER AND/OR APPLICANT IS DRAWN TO THE NEED TO OBTAIN ALL OTHER RELEVANT PERMITS PRIOR TO THE COMMENCEMENT OF WORKS.
