THE PERMIT ALLOWS: Construction of a compact roundabout at the intersection of Remembrance Drive and Maddens Road and Weighbridge Road, Cardigan, generally in accordance with the following documents:

- Madden Road Intersection, Remembrance Drive, Compact Roundabout, Windermere, Regional Roads Victoria, RMG, dated 26 October 2021, Issue A, Drawings 1002, 1101-1103; 1201; 1202; 1301-1305; 2000-2005; 3101-3105; 4101-4105.
- Department of Transport, Remembrance Drive/Madden Road, Compact Roundabout, Aboricultural Impact Assessment, prepared by Civica, dated 14 December 2021.

THE FOLLOWING CONDITIONS APPLY TO THIS PERMIT:

- 1. The permission granted for this permit shall expire if one of the following circumstances applies: the permitted works have not commenced within two (2) years of the original date of issue of this permit, or are not completed within four (4) years of the original date of issue of this permit unless otherwise agreed in writing by the Executive Director, Heritage Victoria.
- 2. The Executive Director, Heritage Victoria is to be given five working days' notice of the intention to commence the approved works.

CONSTRUCTION MANAGEMENT

- 3. Prior to the commencement of any of the works approved by this permit, a **Construction** Management Plan must be provided for endorsement by the Executive Director, Heritage Victoria and once endorsed becomes part of the permit. The Construction Management Plan must include a sequencing program for the approved works, details of any temporary infrastructure and services required, protection methods for the heritage place during the undertaking of the works, and a work site layout plan.
- 4. Prior to the commencement of any of the works approved by this permit a Tree Protection **Plan** prepared in accordance with AS4970 Protection of trees on development sites that references the same version of the drawings submitted for condition 8, must be submitted to the Executive Director, Heritage Victoria for approval. Once approved, the Tree Protection Plan will be endorsed and will then form part of the permit.
- 5. Prior to the commencement of any of the works approved by this permit, a **Tree Removal** Plan, consistent with the recommendations of the Tree Protection Plan approved at condition 4 must be submitted to the Executive Director Heritage Victoria for approval. Once approved,

the Tree Protection Plan will be endorsed and will then form part of the permit.

6. Prior to the commencement of any of the works approved by this permit the name of an Arborist with minimum qualification of Certificate IV Arboriculture or equivalent to be engaged to fulfil the requirements of the Tree Protection Plan approved at condition 4 must be provided to the satisfaction of the Executive Director, Heritage Victoria.

MEMORIAL PLAQUES

7. Prior to the commencement of any of the works approved by this permit, a **methodology for the protection of the memorial plaques** must be submitted to the Executive Director, Heritage Victoria for approval. Once approved, the document will be endorsed and will then form part of the permit. This must include recording and photographing each plaque to ensure the correct plaques are retained for the correct memorial tree on site throughout the works.

CONSTRUCTION READY DRAWINGS

- 8. Prior to the commencement of any of the works approved by this permit, a construction ready (marked as such) set of **drawings for the compact roundabout**, must be submitted to the Executive Director, Heritage Victoria for approval. Once approved, the drawings will be endorsed and will then form part of the permit. These drawings must include signage and lighting, and it must be demonstrated that these are the minimal possible to meet compliance.
- 9. The Executive Director, Heritage Victoria must be notified within one month of the completion of the compact roundabout.

TREE REPLACEMENT

- 10. Within 2 months of satisfaction of condition 9, a construction ready (marked as such) set of **landscape drawings** must be submitted to the Executive Director, Heritage Victoria for approval. Once approved, the drawings will be endorsed and will then form part of the permit. The landscape drawings must document the like-for-like replacement, with super advanced sized nursery stock, of any trees removed in accordance with the Tree Removal Plan at condition 5 and any other related landscape reinstatement works required to the Avenue of Honour.
- 11. The works in the approved landscape drawings at condition 10 must be implemented within the next planting season directly following approval of condition 10.
- 12. Prior to the commencement of planting approved at condition 10, a **Tree Maintenance Plan** for the trees replaced must be submitted to the Executive Director, Heritage Victoria for approval. Once approved, the Tree Maintenance Plan will be endorsed and will then form part of the permit. The Tree Maintenance Plan must document watering, formative pruning, mulching and regular professional condition review to ensure success of replanted trees for three (3) years, and specify a contractor that will implement these works.
- 13. Within **2 months** of satisfaction of condition 9, a **post-construction arborist report** is to be provided to the satisfaction of the Executive Director, Heritage Victoria on the condition of the trees following the works, including any recommendations for actions to mitigate any damage of the approved works on the trees. If any actions are recommended the post-construction arborist report will be approved. Once endorsed it will then form part of the permit and the works must be undertaken within 6 months.

14. Within **1 year** of satisfaction of condition 9, a **post-construction arborist report** is to be provided to the satisfaction of the Executive Director, Heritage Victoria on the condition of the trees following the works, including any recommendations for actions to mitigate any damage of the approved works on the trees. If any actions are recommended the post-construction arborist report will be approved. Once endorsed it will then form part of the permit and the works must be undertaken within 6 months.

GENERAL CONDITIONS

- 15. Should further **minor changes** in accordance with the intent and approach of the endorsed documentation become necessary, correspondence and supporting documentation must be prepared and lodged for assessment by the Executive Director Heritage Victoria who will advise on the approach to be taken to address these matters.
- 16. Approved works or activities are to be planned and carried out in a manner which prevents damage to the registered place/object. However, if other previously hidden original or inaccessible details of the object or place are uncovered, any works that may affect such items must immediately cease. The Executive Director, Heritage Victoria must be notified of the details immediately to enable Heritage Victoria representatives to inspect and record the items, and for discussion to take place on the possible retention of the items, or the issue of a modified approval.
- 17. All works must cease, and Heritage Victoria must be contacted if historical archaeological artefacts or deposits are discovered during any excavation or subsurface works. Should any munitions or other potentially explosive artefacts be discovered, Victoria Police is to be immediately alerted and the site is to be immediately cleared of all personnel.
- 18. The Executive Director, Heritage Victoria must be informed when the approved works have been completed.

NOTE THAT PERMISSION HAS BEEN GIVEN FOR INSPECTIONS OF THE PLACE OR OBJECT TO BE UNDERTAKEN DURING THE CARRYING OUT OF WORKS, AND WITHIN SIX (6) MONTHS OF NOTIFICATION OF THEIR COMPLETION.

TAKE NOTICE THAT ANY NATURAL PERSON WHO CARRIES OUT WORKS OR ACTIVITIES NOT IN ACCORDANCE WITH THE PERMIT OR CONDITIONS IS GUILTY OF AN OFFENCE AND LIABLE TO A PENALTY OF 120 PENALTY UNITS (\$19,826 AS AT JULY 2019) OR IN THE CASE OF A BODY CORPORATE 600 PENALTY UNITS (\$99,132 AS AT JULY 2019) UNDER s104 THE HERITAGE ACT 2017.

WORKS UNDERTAKEN WITHOUT A PERMIT OR PERMIT EXEMPTION CAN INCUR A FINE OF UP TO 4800 PENALTY UNITS (\$793,056 AS AT JULY 2019) FOR A NATURAL PERSON OR 5 YEARS IMPRISONMENT OR BOTH AND UP TO 9600 PENALTY UNITS (\$1,586,122 AS AT JULY 2019) IN THE CASE OF A BODY CORPORATE UNDER SECTION 87 OF THE HERITAGE ACT 2017.
