

INTRODUCTION

TCL was commissioned in April 2023 to undertake a review and landscape design proposal for the Jockeys' Convalescent Lodge built in 1893 and located at 550 Epsom Road, Flemington. The building was intended to house injured jockeys after their release from hospital it was said to be 'admirably situated' and 'adapted for the requirements of a recuperative seminary' 1. Given the heritage listing TCL reviewed the Heritage Impact Statement and established heritage principles to ensure the proposal is in accordance with the heritage value of this building and landscape.

The proposed design aims to embody the Burra Charter to ensure a legible reading of the historical building while ensuring a contemporary garden experience to evoke the expression of a garden for recuperation and enjoyment. The proposal seeks to ensure the garden becomes a landscape that is utilised by residents and visitors for passive recreation and enjoyment.


The landscape proposal seeks to reinforce the perimeter hedge with a communal seat element. complimented with informally arranged domestic scaled trees.

The 1945 images are all that remain to hint towards the heritage garden that once was here, along with an image from circa 1965. The contemporary garden design proposal has based the domestic scaled ornamental and fruiting trees that appear in the 1965 image.

The garden will play a critical role in establishing the views to the heritage building and invite the public to enjoy this important heritage building and setting.




Convey a sense of being a part of respite and convalescences

- Respect and acknowledge the heritage building an octagonal exotic Victorian cottage by William Salway in the orne' style
- planted with a hedge to provide restful seclusion for the convalescent of jockeys



Views from Epsom Road and distant views beyond

- maintain views from Epsom Road to the building
- maintain a good view from the lawn to the west




Perimeter and hedge to create a sense of enclosure

- provision of a planted hedge or curved natural stone path as interpretive element of hedge




Access Path

- provision of a path leading from the front door of the lodge to the perimeter garden




Limit Access / New Access Points

Retention of Peppercorn Tree and plant usage

Loose arrangement of gardens based on octagonal form

- Acknowledge the unusual polygonal design within a circular garden setting to provide seclusion

Domestic Scale to support rehabilitation

- garden to reflect the heritage function of the building however not to be a heritage garden

Mitigate scale of proposed architecture

- garden to establish a sense of enclosure and assist in mitigating the scale of the proposed buildings

Enhanced garden setting to support future cafe' use

- the contemporary garden can be utilised to support the future buildings function as a cafe' and place of social gathering



















Proposed Redevelopment of Heritage building by Lovell Chen Refer Architecture Package

FACADE PLANTERS TO PROPOSED BUILDING




Facade planters create vertical green infrastructure to provide a softening to the facade.

The proposed vertical greening is to integrate the planter element behind the facade element with a GRC or similar container system. All planters will have integrated irrigation and maintenance access by the facade access strategy.

Plants have been proposed to be hardy and provide seasonal change. The plants include a consistent green character once established.
