THE PERMIT ALLOWS: Temporary installation of a Ferris wheel on the lawn area adjacent to St Kilda Yacht Club building within the Catani Gardens between December 2021 and March 2022, in accordance with the following documents, as endorsed by the Executive Director and forming part of this permit:

- Heritage Impact Statement, prepared by Frontier Heritage Pty Ltd, dated 26 October 2021.
- Drawings prepared by Frontier Heritage Pty Ltd, dated 26 October 2021:
  - A01 Location and Site Plan
  - A02 Ferris Wheel Plan
- Catani Gardens Heritage Conditions (event usage), prepared by Port Phillip City Council, undated.
- Skyline Attractions Bump-In Schedule, undated.
- Skyline Attractions Bump-Out Schedule, undated.

## THE FOLLOWING CONDITIONS APPLY TO THIS PERMIT:

- 1. The permission granted for this permit shall expire if one of the following circumstances applies: the permitted works have not commenced within two (2) years of the original date of issue of this permit, or are not completed within four (4) years of the original date of issue of this permit unless otherwise agreed in writing by the Executive Director, Heritage Victoria.
- 2. The Executive Director, Heritage Victoria is to be given one days' notice of the intention to commence the approved works.
- 3. At the conclusion of the event, and prior to 30 April 2022, the following condition reports for the works area within the Catani Gardens are to be prepared by fully qualified professionals (independent from the event) and must be provided for endorsement by the Executive Director, Heritage Victoria and once endorsed becomes part of the permit:
  - a) Post-event condition report, including impacts and repair actions (including but not limited to aerating, scarification, top dressing, over seeding and fertilising of grassed areas), any variations to the approved documents and recommendations for outstanding repair actions.

- b) A soil compaction assessment, based on the condition of the Place after the event, including recommendations for future soil protection.
- 4. The works approved by this permit are to be carried out in accordance with the endorsed documentation, unless otherwise agreed in writing by the Executive Director, Heritage Victoria.
- 5. Should further minor changes in accordance with the intent and approach of the endorsed documentation become necessary, correspondence and supporting documentation must be prepared and lodged in accordance with the permit condition for assessment by the Executive Director, Heritage Victoria who will advise on the approach to be taken to address these matters.
- 6. Approved works or activities are to be planned and carried out in a manner which prevents damage to the registered place. However, if other previously hidden original or inaccessible details of the object or place are uncovered, any works that may affect such items must immediately cease. The Executive Director, Heritage Victoria must be notified of the details immediately to enable Heritage Victoria representatives to inspect and record the items, and for discussion to take place on the possible retention of the items, or the issue of a modified approval.
- 7. All works must cease, and Heritage Victoria must be contacted if historical archaeological artefacts or deposits are discovered during any excavation or subsurface works. Should any munitions or other potentially explosive artefacts be discovered, Victoria Police is to be immediately altered and the site is to be immediately cleared of all personnel.
- 8. The Executive Director, Heritage Victoria must be informed when the approved works have been completed.

NOTE THAT PERMISSION HAS BEEN GIVEN FOR INSPECTIONS OF THE PLACE OR OBJECT TO BE UNDERTAKEN DURING THE CARRYING OUT OF WORKS, AND WITHIN SIX (6) MONTHS OF NOTIFICATION OF THEIR COMPLETION.

TAKE NOTICE THAT ANY NATURAL PERSON WHO CARRIES OUT WORKS OR ACTIVITIES NOT IN ACCORDANCE WITH THE PERMIT OR CONDITIONS IS GUILTY OF AN OFFENCE AND LIABLE TO A PENALTY OF 120 PENALTY UNITS (\$21,808.80 FROM 1 JULY 2021) OR IN THE CASE OF A BODY CORPORATE 600 PENALTY UNITS (\$109,044 FROM 1 JULY 2021) UNDER \$104 THE HERITAGE ACT 2017.

WORKS UNDERTAKEN WITHOUT A PERMIT OR PERMIT EXEMPTION CAN INCUR A FINE OF UP TO 4800 PENALTY UNITS (\$872,352 FROM 1 JULY 2021) FOR A NATURAL PERSON OR 5 YEARS IMPRISONMENT OR BOTH AND UP TO 9600 PENALTY UNITS (\$1,744,704 FROM 1 JULY 2021) IN THE CASE OF A BODY CORPORATE UNDER SECTION 87 OF THE HERITAGE ACT 2017.
