

- 8. PRIOR TO COMMENCEMENT OF WORKS ALL MOLDINGS IN AREA OF WORKS TO BE ACCURATELY RECORDED.
- 9. CLEAN AND REMOVE GUANO, DEBRIS AND DUST AND LIKE FROM AREA OF WORKS.
- 10. PRIOR TO THE COMMENCEMENT OF DEMOLOTION WORKS, ON THE TWO CANTED BAY STRUCTURES ON THE SOUTH AND EAST ELEVATIONS OF THE TOWER, BOTH STRUCTURES MUST BE PROPED FROM FLOOR TO ROOF.
- 11. DEMOLISH CONCRETE COLUMN AND PLINTH STRUCTURE ON SOUTH AND EAST CANTED BAY STRUCTURE. REMOVING, RETAINING AND STORING ALL PRECAST CONCRETE MASHRABIYYAH PANELS. DUE TO HEAVY CRACKING AND SPALLING THE COLUMN AND PLINTH STRUCTURE CAN NOT BE REMOVED IN ONE PIECE THE FOLLOWING DEMOLITION METHODOLOGY IS PROPOSED.
- 11.1 CUT VERTICALLY DOWN CONCRETE COLUMN, REMOVING SECTION PINNING MASHRABIYYAH SCREENS.
- 11.2 CAREFULLY REMOVE AND STORE PRECAST MASHRABIYYAH SCREENS (APPROX 800MM HIGH) IN TOWER.
- 11.3 CAREFULLY DEMOLISH AND REMOVE THE REMAINDER OF THE PRECAST CONCRETE COLUMN AND PLINTH.
- 12. REMOVE AND RETAIN OF ALL CRENELATIONS DEEMED TO BE IN POOR CONDITION. THIS IS EXPECTED TO BE ALL CRENELLATIONS ON THE TOWER AND A LOCALISED NUMBER FROM THE SOUTH AND EAST ELEVATIONS (APPROX.12).
- 12.1 VERTICALLY CUT THE BASE OF EACH INDIVIDUAL EXISTING CONCRETE CRENELLATION SEPARATING IT FROM THE CRENELATIONS ON EITHER SIDE.
- 12.2 INDIVIDUALLY CUT EACH EXISTING CONCRETE CRENELATION HORIZONTALLY ALONG MOLDING LINE.
- 13.3 INDIVIDUALLY REMOVE CONCRETE CRENELATIONS AND STORE IN THE TOWER. CRENELATIONS THAT COLLAPSE DURING REMOVAL TO BE DISPOSED OF AND REPLACED IN FUTURE WORKS.
