**THE PERMIT ALLOWS:** Upgrade of the John Butler Reserve including demolition of the existing amenity block and construction of a new amenity block in a different location; removal of the existing playground and installation of a new playground; and landscaping works including revegetation of the carpark median, relocation of the fence to the dog off-leash area and other general landscape works, in accordance with the following documents, as endorsed by the Executive Director and forming part of this permit:

- **John Butler Reserve Landscape Drawings** prepared by URBIS, numbered 001-CS(REV D), 151-DE(REV A), 152-DE (REV A), 201-FI (REV D), 202-FI(REV D), 501-PL(REV C), 520-PL (REV C), 601-FR (REV D), 602-FR (REV D), 901-DT (REV B), 902-DT (REV C), 903-DT (REV A), 904-DT (REV A)
- **John Butler Reserve Mt Eliza, Landscape Concept Plan - Playground**. LA-01(REV B), prepared by URBIS, dated 06.04.18
- **John Butler Reserve Mt Eliza, Landscape Concept Plan - Car Park Island**. LA-02(REV B), prepared by URBIS, dated 06.04.18

THE FOLLOWING CONDITIONS APPLY TO THIS PERMIT:

1. The permission granted for this permit shall expire if one of the following circumstances applies: the permitted works have not commenced within two (2) years of the original date of issue of this permit, or are not completed within four (4) years of the original date of issue of this permit unless otherwise agreed in writing by the Executive Director, Heritage Victoria.
2. The Executive Director, Heritage Victoria is to be given five working days' notice of the intention to commence the approved works.
3. Approved works or activities are to be planned and carried out in a manner which prevents damage to the registered place/object. However, if other previously hidden original or inaccessible details of the object or place are uncovered, any works that may affect such items must immediately cease. The Executive Director, Heritage Victoria must be notified of the details immediately to enable Heritage Victoria representatives to inspect and record the items, and for discussion to take place on the possible retention of the items, or the issue of a modified approval.

4. All works must cease, and Heritage Victoria must be contacted if historical archaeological artefacts or deposits are discovered during any excavation or subsurface works. Should any munitions or other potentially explosive artefacts be discovered, Victoria Police is to be immediately alerted and the site is to be immediately cleared of all personnel.
5. The Executive Director, Heritage Victoria must be informed when the approved works have been completed.

**NOTE THAT PERMISSION HAS BEEN GIVEN FOR INSPECTIONS OF THE PLACE OR OBJECT TO BE UNDERTAKEN DURING THE CARRYING OUT OF WORKS, AND WITHIN SIX (6) MONTHS OF NOTIFICATION OF THEIR COMPLETION.**

**TAKE NOTICE THAT ANY NATURAL PERSON WHO CARRIES OUT WORKS OR ACTIVITIES NOT IN ACCORDANCE WITH THE PERMIT OR CONDITIONS IS GUILTY OF AN OFFENCE AND LIABLE TO A PENALTY OF 120 PENALTY UNITS (\$19,826 UNTIL 30 JUNE 2020; \$21,808.80 FROM 1 JULY 2021) OR IN THE CASE OF A BODY CORPORATE 600 PENALTY UNITS (\$99,132 UNTIL 30 JUNE 2020; \$109,044 FROM 1 JULY 2021) UNDER s104 THE HERITAGE ACT 2017.**
